The owner of the company is the **Hungarian State**. The proprietorial rights are exercised by the **Hungarian National Asset Management Inc.** (1133 Budapest, Pozsonyi út 56). in accordance with the Act CVI of 2007. 3. § (1). on state assets. The financing of the company's activities is provided by the **Ministry of Energy** (1011 Budapest, Október Huszonharmadika u. 18.) through support derivated from the central budget.

The company is a prominently public benefit organization.

The scope of the Company is to perform the state public duties and contribute to their execution such as the cessation of the remained environmental and property damages after the termination of mining activities, handling the allowances of workers employed in coal mining, casualty allowance and other work-related compensations in duties occurred in uranium mining until 31 December 1993, as well as the managment of the state owned hydrocarbon wells.

In the course of its public benefit activities, the Company performs such public tasks and contributes to their implementation that are assigned to public organizations regulated by

- a) the Act No. LIII 38. § a-b) points of 1995 on the General Rules of Environmental Protection and
- b) the Gov. Decree No. 94/2018. (V.22) 88. § (1) d) point and (2) d) point on the Tasks and Powers of Members of the Government.

The Company's administrative supervisor is the Ministry of Innovation and Technology,

the Tax Authority competent by the company's registered seat is authorised to exercise tax control over the Company,

the National Audit Office is authorised to exercise control over the use of budget support,

the supervision of the legality of the Company regarding public benefit operations is provided by the prosecutor's office.
